LETTER OF NO OBJECTION

Brand: F2-21 Nano Tech and eeFuel (marketed also under the brand names: CG-7, Less, Nanoplus, AutoMax NFE, Power Booster)

Dear Sirs,

The information submitted to us of the above mentioned F2-21 Nano Tech fuel additive has been evaluated by Wärtsilä Industrial Operations. In consideration of the information You have disclosed to us concerning the composition and properties of this product, Wärtsilä has no objection to the use of this fuel additive in the following engine types:

Wärtsilä® 20, 26, 32, 38, 46, 46F, 64, Vasa 22, 22/26, 32/32LN and Sulzer ZA 40

No Objection for the use of the above mentioned fuel additive in other older Wärtsilä® engine types manufactured by Wärtsilä can be requested from Wärtsilä Services units being responsible for a particular engine type in question.

Based on the information received from H2OIL Corporation, the additive is essentially an ashless product when blended in accordance with the manufacturer's instructions. This additive treat rate is not considered to be harmful to the engine or its operation when used in terms of these recommendations. Further, the fuel quality at engine inlet must meet the relevant Wärtsilä requirements under all operating conditions.

Wärtsilä does not assume any responsibility for the function of this additive and does not guarantee that the indicated improvements concerning reductions in the fuel consumption / emissions / engine component deposit formation rate are achievable in the Wärtsilä® engine types mentioned above.

Wärtsilä disclaims any and all responsibility for damage or losses in case a customer uses the above mentioned fuel additive during the engine warranty period and thereafter.

The supplying fuel additive company H2OIL Corporation along with other distributors of the product in question undertake any and all responsibility for the performance of the fuel additive in service of Wärtsilä® engines listed above to the exclusion of any liability of Wärtsilä.

Nothing in this Letter of No Objection shall affect any rights of Wärtsilä or any company belonging to Wärtsilä group, neither shall this Letter of No Objection provide the H2OIL Corporation along with other distributors of the product in question with any right or license under any patents, copyrights, trade secrets, or trademarks. H2OIL Corporation along with other distributors of the product in question shall honour and refrain from using or referring to the trademarks or trade names (as for example Wärtsilä®) owned or generally used by Wärtsilä and any company belonging to Wärtsilä group. H2OIL Corporation along with other distributors of the product in question is not allowed to use the name “Wärtsilä” in its reference list without the prior written consent of the authorized representative Wärtsilä.

The validity of this Letter of No Objection is confined to max. twenty four (24) months after the date of publication unless a further notice is given before that. Based on the gathered experience the validity can be extended after the expiry date. Wärtsilä shall at its sole discretion have the right at any time to withdraw this Letter of No Objection.
